ORDINANCE Numbered 418

AN ORDINANCE FURTHER AMENDING SECTION ONE OF ORDINANCE NUMBERED SIXTY-SIX, AS AMENDED BY ORDINANCE NUMBERED 329; PROVIDING PENALTIES; AND FOROTHER PURPOSES.

ON MOTION OF COUNCILORS BUGNOSEN, CLARAVALL AND PARAAN, SECONDED BY COUNCILOR FANGONIL, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BAGUIO, THAT:

SECTION 1. - Section 1 of Ordinance No. 66, as amended by Ordinance No. 329, be, as it is hereby, further amended to read as follows:

"Section 1. Motorcycles, tricycles, scooters, bicycles or motorbikes prohibited: penalty. - Except those intended for hire at Burnham Park, and except those used exclusively for the delibery of messages by telegram, telephone, radio and other communications services, which have branch offices in the City of Baguic, the use of motorcycles, tricycles, scooters, bicycles, or motorbikes on the roads, streets or bridle paths within the limits of the City of Baguio is hereby prohibited; PROVIDED, that any person residing without the city limits and entering the same on a motorcycle, tricycle, scooter, bicycle or motorbike may proceed direct to his destination therein by the nearest route, and ride such motorcycle, scooter, bicycle, tricycle or motorbike out of the City also by the nearest route; PROVIDED FURTHER, That for sigh-seeing and/or recreational purposes for non-residents or Baguio visitors, the City Mayor may issue permit therefor for a limited period only, excluding the use of Session Road, Magsaysay Avenue, General Luna Road and other streets and . roads with heavy traffic at certain periods of the year; PROVIDED FURTHERMORE, that operators of scooters, tricycles, motorcycles, bicycles or motorbikes for hire at Burnham Park may be allowed by written authority of the Mayor, to use one of their vehicles for "service", to enable them, in case of emergency, to buy fuel, spare parts and other things essential to their business. Such vehicle should bear a plate conspicuously marked FOR SERVICE ONLY; PROVIDED FURTHERMORE, that managers of telephone, telegram, radio or other communications companies, which have branch offices in the City of Baquio, shall register in the Police Department the number of scooters, motorcycles, tricycles, bicycles, or motorbikes being used by them for the delivery of messages and such vehicles should bear a plate conspicuously marked COMMUNICATION SERVICE: PROVIDED FURTHERMORE, that wirtten authority of the City Mayor shall be obtained for the use of such scooters, tricycles, motorcycles, bicycles or motorbikes by the managers of telephone, telegram, radio or other communications companie which have branch offices in the City; and PROVIDED FINALLY, that no company shall have more than two units at any one time

"Each violation of any of the provisions hereof shall be punished by a fine of not more than fifty pesos, or by imprisonment of not more than thirty days, or by both such fine and imprisonment in the discretion of the court."

SEG. 2 - This Ordinance shall take effect upon its approval.
